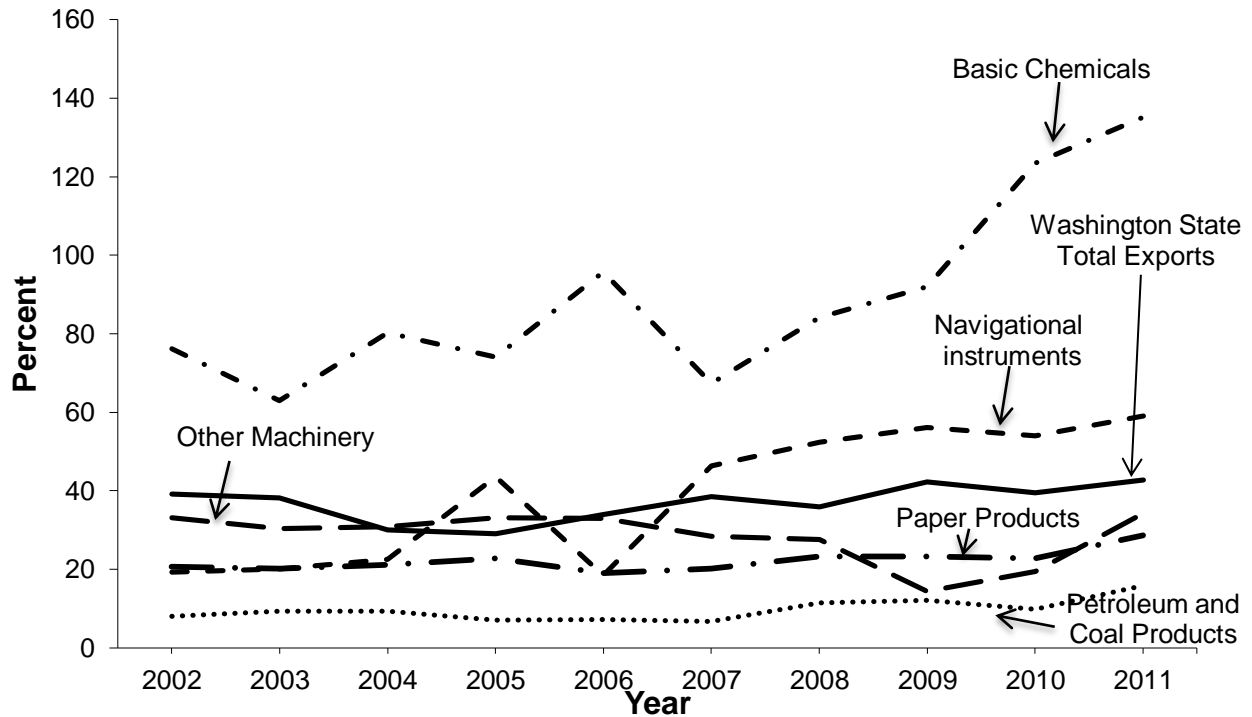


Graph 4: Percent of Total Shipments Exported to the World for Five Washington State Industries by Year
